Item No.9.5: - To approve the modification in Ordinance No. 02 entitled "Grace Marks for getting Higher Class"

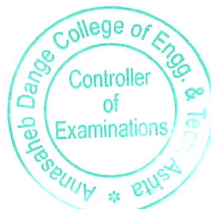
Prof. V B Patil proposed the modification in ordinance no. 02, mentioning its importance as follows, The additional **Ordinance No. 01 and Ordinance No. 02** were proposed by the office of the controller of examinations at the **2nd Institute Examinations Committee (IEC)** meeting held on dated **19.12.2017**, which was unanimously resolved by the said committee and followed by its confirmation at the Academic Council meeting. The unanimously undertaken ordinance is as follows,

Confirmed Ordinance

Ordinance No. 01:-

Grace Marks at ESE

The student will be confirmed with grace marks with eligibility and methodology as mentioned below,



The student is eligible for a maximum of four grace marks in each semester if they fulfill the following criteria,

- I. With the grace marks, a student will be able to acquire a "D.D." grade in all courses of that semester.
- II. The grace marks should be allotted to a maximum of two courses to get a "D.D." grade.
- III. He / She is eligible to get a maximum of four marks either in Total Marks [100 Marks] (ISE + MSE + ESE) OR Two Marks in ESE [50 Marks] to clear the 40 % eligibility in a particular case whenever it is necessary.

Confirmed Ordinance

Ordinance No. 02:- Grace Marks for getting Higher Class

A candidate whose overall result is "Pass" at the final year of his/her graduation and not received a benefit of grace marks as per ordinance no. 01 at the last semester of his/her graduation and whose CPI is short for securing Second Class or First Class.

i) U.G. Level

This grace mark will be confirmed to a candidate with the above eligibility, with not more than 01 (One) percent of the aggregate marks at the final semester of the program or up to a maximum of 10 (ten) marks, whichever is less, shall be given the required marks to get the next higher class or grade as the case may be.

ii) P.G. Level

This grace mark will be confirmed to a candidate with the above eligibility, with not more than 01 (One) percent of the aggregate marks at the final year of the program or up to a maximum of 06 (six) marks, whichever is less, shall be given the required marks to get the next higher class or grade as the case may be.

Proposed Modification in the Ordinance No. 02

Ordinance No. 02:- Grace Marks for getting Higher Class

A candidate whose overall result is "Pass" at the final year of his/her graduation and not received a benefit of grace marks as per ordinance no. 01 at the last semester of his/her graduation and whose CPI is short for securing Pass class, Second Class, or First Class.

i) U.G. Level and P.G. Level

A Grace of 1% of maximum CGPA of 10 is given to the student only at 8th-semester CGPA if it helps the student secure the higher class, i.e, to secure minimum pass class (CGPA 4.75, second class, first class/first class with distinction). It is not given for any other reason.



It is also proposed that students' grace mentioned above be given to get the higher class. If a candidate is willing to opt for CPI improvement, he/she can appear for the CPI improvement examination. The competent authority will declare the schedule of such examination from time to time.

CPI Improvement Policy for Award of Degree

Opportunity shall be given to a student who has earned all the credits required by the respective program and is willing to earn a higher class with improved CPI with subsequent examinations. In such a case, no grade penalty is applicable. In case of improvement, the best of two performances between old and new CPI will be considered to declare the results.

For U.G. Student

In the improvement examination, the student can select a maximum of five theory courses either from the seventh or eighth semester for appearing in the examination. The examination fee is applicable as competent authorities decide from time to time for applying improvement in CPI.

For P.G. Student

In the improvement examination, the student can select a maximum of two theory courses either from the First or Second semester for appearing in the examination. The examination fee is applicable as time to time decided by competent authorities for applying for improvement in CPI.

Dr. Vikram Patil and Dr. Suyogkumar Taralkar also mentioned the need for modification required in ordinance 02. Shri. G R Palase confirmed that the proposed ordinance is in line with Shivaji University, Kolhapur, and mentioned that the same facility is already in place at Shivaji University, Kolhapur, as per ordinance O-91 (U.O 02) House unanimously approved the proposed ordinance and effective from academic years 2020-21.

All members participated in the discussion. Member secretary agreed and assured meeting for implementation it in upcoming days. Prof. Sachin Patil had given a vote of thanks, and the meeting concluded.
