# Methodologies for Class Improvement Examination (UG)

As per the unanimously consented decision at the Core Committee meeting held on 25.06.2021, it confirmed that a single chance should be given to the eligible under graduated students willing for the class improvement. This opportunity shall be given to such a student who has earned all the credits required by the respective program and is willing to achieve a higher class (Namely second class, first class/first class with distinction) with improvement in CPI.

# A) Eligibility

The regular student (passed out in the academic year 2021-2022) of all undergraduate programs appeared at Final Year B. Tech. (ME, ET, CS, EE, CV, AU, AE) for any End Semester Examination (ESE) / End Semester Re-Examination (Re\_ESE) / 100 % Examinations during the previous academic year 2021-2022 and not confirmed the graduation at convocation by Shivaji University, Kolhapur.

#### And

His/her overall result at Final Year B. Tech. (ME, ET, CS, EE, CV, AU, AE, FT) for the last examination declared by the office of Controller of Examinations is "Pass" and CPI is more than 4.75.

## B) Methodology and Schedule

The Class Improvement Examination (UG), Aug. 2022 for the academic year 2021-2022 is proposed to be scheduled for the first or second week of Aug. 2022. The detailed final examination scheduled is notified and will be declared in due course of time.

## C) Rules and Regulations applicable:

- 1. Eligible students need to apply with a prescribed application form and pay the applicable examination fee from 20.06.2022 to 09.07. 2022. Any application received after mentioned date will not be processed in circumstances.
- In the case of the Class Improvement Examination (UG), Aug. 2022 the student can opt for a maximum of five
  theory courses either from the seventh or eighth semester for appearing in the examination. Once the courses are
  selected, they can not be modified.
- 3. Students can not opt for any practical course, project/mini project/ industrial training, etc., for class improvement examinations.

- 4. In class improvement examinations, the best of two performances between old and new CPI will be considered for the declaration of the results.
- 5. Suppose any student is found exercising malpractice during a class improvement examination. In this case, his/her CPI will be canceled/suspended. They then need to appear before the Primary Investigation Committee (PIC):

## D) Methodology:

- 1. The upcoming "Class Improvement Examination, Aug 2022" is proposed to be conducted in Offline Mode.
- 2. The question paper pattern will be based on the whole syllabus (In line with 100 % examination without any grade penalty) mentioned for the said course in the notified curriculum.
