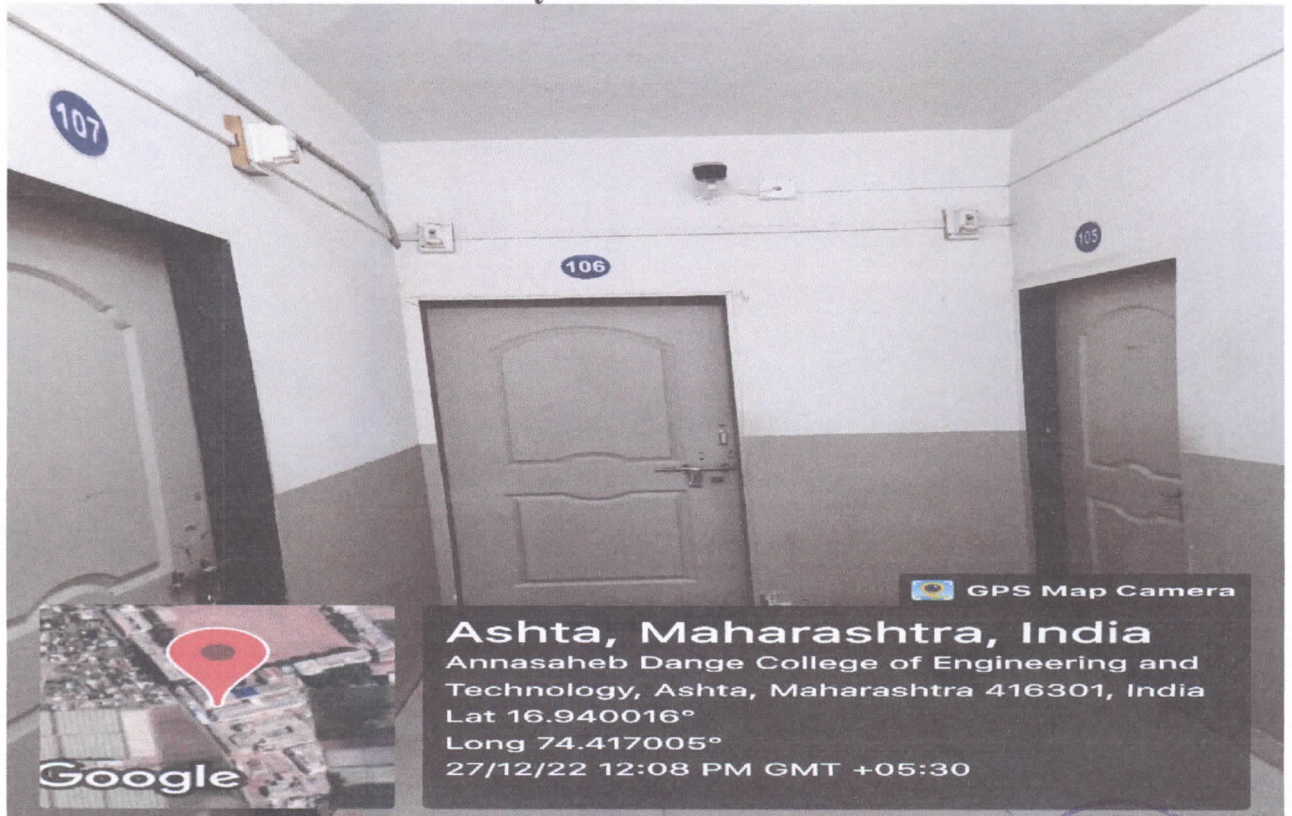

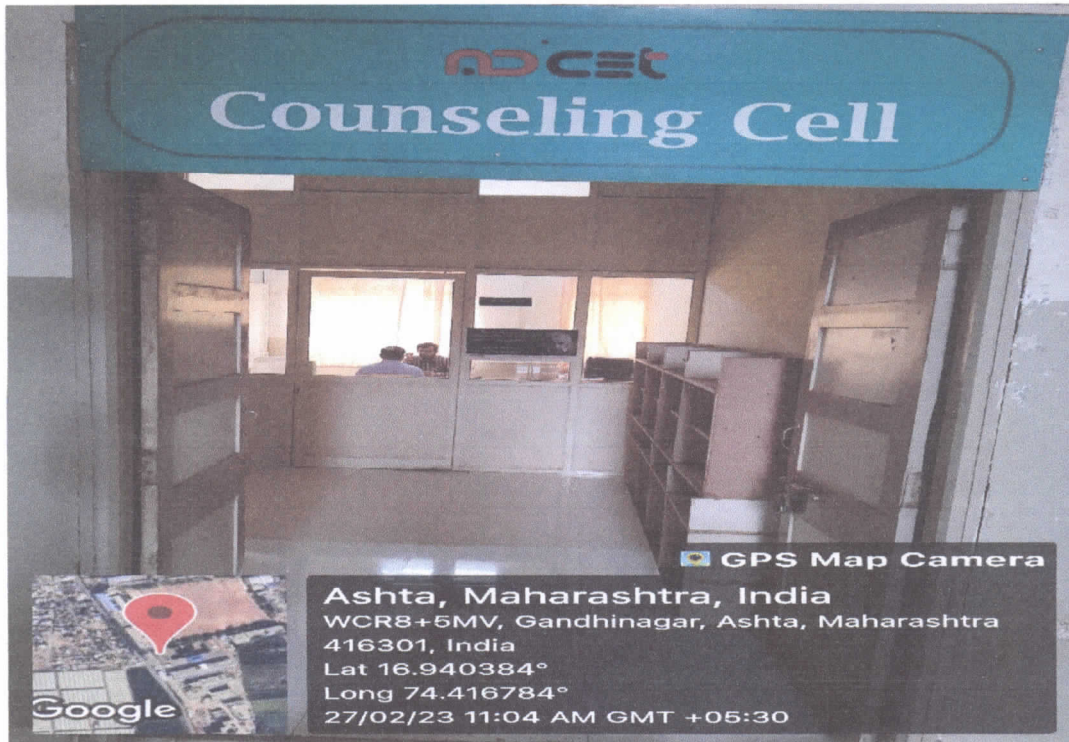


Security Camera installed in Hostel

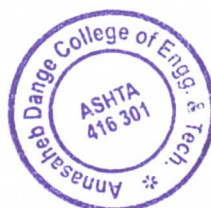


GPS Map Camera
